### Type D Calling Plan Discount Schedule

Discounts to Type D Switched or Dedicated Outbound or Inbound calling charges are available based on the Customer's contract term length and their committed Minimum Monthly Revenue Charges. Discounts apply only to calls originating and terminating within the continental USA. The per minute rate for calls eligible for the discount will be reduced by the percentage discount defined for the corresponding contract term length and their committed Minimum Monthly Revenue Charges, as shown in the table following.
